



## Early Ordering Program – Terms & Conditions (Back-to-School 2027)

### 1. Offer Overview

The Weareco Early Ordering Program (“Offer”) provides eligible customers with the opportunity to secure pricing, priority delivery, and a 7.5% discount on Back-to-School 2027 Indent Orders, subject to the terms outlined below.

### 2. Eligibility

- The Offer is available to approved wholesale customers placing Indent Orders for Back-to-School 2027.
- A minimum order value of AUD \$10,000 (ex GST) applies.
- The Offer applies to Indent items only and excludes holding stock, new orders, or top-up orders placed after the applicable deadlines.

### 3. Lock-In Pricing Period

- Orders placed between 1 April 2026 and 31 May 2026 are eligible to secure current pricing.
- Orders placed after 31 May 2026 may be subject to price adjustments due to changes in raw material costs, freight, or global supply conditions.

### 4. Early Advantage - Priority Delivery by 31 October 2026

To qualify for customers must:

- Place their order by 31 May 2026, and be approved by Weareco by 6 June 2026.

Failure to meet the above milestone may result in eligibility for priority delivery to be withdrawn.

### 4. Early Advantage Saver – 7.5% Discount & Priority Delivery by 31 October 2026

To qualify for the 7.5% discount & priority delivery, the total Indent Order value, customers must:

- Place their order by 31 May 2026, and be approved by Weareco by 5 June 2026
- Pay a 30% deposit by 30 June 2026

Failure to meet any of the above milestones may result in the Offer being withdrawn or delivery delays.

### 5. Payment Terms

- For Early Advantage saver, a 30% deposit is required to activate production.
- Any remaining balance is payable 30 days from delivery in accordance with agreed trading terms prior to dispatch unless otherwise approved in writing.

Late payments for B2S 2027 Indent Orders may result penalty credit terms and or result in required deposits for future orders in the subsequent year.

### 6. Delivery & Supply

- Priority delivery for eligible orders is scheduled for on or before 31 October 2026.
- Orders placed by 31 July 2026 will support delivery readiness for January Back-to-School 2027.
- While Weareco will use all reasonable endeavors to meet delivery timelines, delays caused by factors outside our control (including but not limited to global supply chain disruption, freight delays, or force majeure events) may impact delivery dates.

#### 7. Product Scope

The Offer applies to existing school uniform lines and approved Back-to-School Indent ranges only. New product developments, customised garments, or fabric changes may require additional lead times and are subject to separate pricing, sampling and approval schedules.

#### 8. Variations & Amendments

Any changes to confirmed orders after 31 May 2026 or late deposit payment may:

- Void the 7.5% discount
- Impact pricing and delivery timelines
- Variations may be subject to revised pricing, minimum order quantities, and extended lead times.

#### 9. Cancellations

Indent Orders are non-cancellable once production has commenced. Deposits are non-refundable except where required by law.

#### 10. Pricing Disclaimer

Pricing is based on current cost structures at time of order. Weareco reserves the right to adjust pricing for orders not secured within the Lock-In Pricing Period due to fluctuations in raw materials, labour, or exchange rates.

#### 11. Discount Conditions

The 7.5% discount applies to the total value of eligible Indent items only.

The discount cannot be combined with any other promotional offer, rebate, or pricing agreement unless approved in writing by Weareco. Does not apply to Holding Stock Orders / purchases. The discount is not transferable or redeemable for cash.

#### 12. Compliance & Quality Assurance

All garments are produced in accordance with Weareco's quality assurance standards and relevant Australian compliance requirements. Any claims relating to defects must be submitted in accordance with Weareco's standard returns and warranty policy.

#### 13. General

By placing an order under this Offer, the customer agrees to these Terms & Conditions.

Weareco reserves the right to amend or withdraw the Offer at any time prior to order confirmation.
